# The Perfect Storm?

The State of Florida seems to have dodged a bullet this past week as Hurricane Dorian continues to weaken and appears to be headed out to sea. However, Florida.



nicknamed the "Gunshine State" because of its high percentage of CC Permit Holders and relatively permissive gun laws took, is once again serving as the model for proposed legislation around the country. Three weeks after the Parkland Shooting, then Governor Rick Scott, signed the Marjory Stoneman Douglas High School Public Safety Act. While there were some good changes in that bill, there were also some gun control restrictions that will no doubt effect law abiding citizens including.

- Raising the minimum age to purchase a long gun from 18
  to 21.
- Mandatory three day waiting period to purchase a

firearm, unless you are а licensed hunter, licensed concealed carrier, police officers or military member. ■ Ban bump stocks. ■ Implement Red Flag Laws SO Law enforcement agencies will be able to petition court for temporary order that stops а person from purchasing possessing

Florida Man Has Firearms Rights Taken Away Over Mistaken Identity

This month, instead of focusing solely on the latest Gun Rights Infringements, the

latest Active Shooter Event, the troubles with the NRA, Corporate Virtue Signaling, or outrageous criminal acts, we are going to try and paint a picture of a bigger storm that has been brewing for years.

This storm began to churn in 2012 when a pair of mass shootings in Aurora, CO and Newtown, CT shocked the nation. These events brought the "Assault Weapon" back into the media's cross-hair. The unthinkable tragedy in Sandy Hook also caused panic buying from gun owners who feared copy cat shootings and massive gun regulations. Gun sales soared as people purchased guns and sought training to obtain their carry permits. Store shelves were empty and people stood in lines to buy guns and ammunition. It took a full 2 years before the availability of firearms and ammunition resembled something close to normal.

Just as the fears and panic buying started to subside, the events in Ferguson, MO in June 2014 changed the way Police Officers were viewed by segments of media, politicians, and society. The Ferguson Effect, as it was deemed, forced law enforcement to drastically change the way they police. Then with the July 2016 attack on Dallas Police officers and repeated targeting and incidents of public humiliation, some officers are becoming more discouraged and have decided to leave law enforcement all together. As anti-police sentiment continues to linger, departments have seen a drop in the number of new recruits entering the police academies. With a smaller police force, and increased anti-police sentiment, departments will continue to have to adjust their policies which will likely mean, less criminal arrests and longer emergency response times.

This means that we, the law abiding citizens, are going to have to deal with longer response times when faced with violent criminals like the Maurice Hill a 6-time convicted felon that injured 6 police officers in a 7 hour standoff in Philadelphia last month. Add in the craziness of Sanctuary Cities and laws such as the First Step Act where "violent criminals and sex offenders" were released early, and you have the beginning of a major storm.

The recent events in El Paso and Dayton have once again brought Red Flag Laws, Universal Background Checks, and another Assault Rifles/Assault Weapons ban to the front page. At a time when we are facing an uptick in violent crime rates (which have been steadily falling since the mid 1990's), and active shooter events, a police shortage, longer emergency response times, and a larger number of criminals on the streets, do we really think it is a good idea to pass more gun control laws? Even the CDC says that firearms serve as a deterrent against crimes as much at 3 million times a year, that is more than 8,000 times a day.

This storm has been building for years, and it is predicted to make landfall in 2020. Currently we are staring at a CAT 5 storm due to embolden anti-gun groups and a weakened NRA. If we are unable to hold back the storm surge in 2020 we will likely be forced to face future storms with far less resources. Those who have lived

through hurricanes and other natural disasters quickly learn that YOU ARE ON YOUR OWN, and you SHOULD NOT rely on your government to save you. Tom Gresham, with Gun Talk, talks about the importance of being prepared when he recounts the aftermath of Hurricane Katrina in his article "Fourteen Years Ago."

"The images of the situation where there are no police officers prompted many around the country to re-evaluate their personal safety plans. Many bought guns and got training."

During Hurricane Katrina, over 1,800 people lost their lives, due "mainly to government incompetence and greed." In addition, the government began unconstitutionally confiscating firearms from citizens when they arguably needed them the most. If nothing else, Katrina, gives us a glimpse of what future tragedies may look like if we don't act now.

Recently we met with the Senior Policy Adviser for one of our Mississippi members of Congress here at Boondocks. We talked specifics about how Red Flag Laws, Universal Background Checks, Magazine Capacity Restrictions and a new Assault Weapons Ban, would do nothing to stop violent crime or mass shootings and would only infringe on the ability of law-abiding citizens to be able to purchase firearms or protect themselves. While they generally oppose new gun control legislation, they admitted it can be difficult for those living and working on Capitol Hill to understand the exact impact a new law will have on their constituents in a state like Mississippi. However, they made it abundantly clear, that our representatives LISTEN TO THE PHONE CALLS from their constituents!

One phone number, 202-224-3121, gets you both the Senate and the House. All of us should be calling the White House to let President Trump know we do not support any "compromise" that involves any form of gun control. That number for the White House is 202-456-1111. If we make the calls, we win. It's that simple. Don't leave it to someone else, let's burn up those phone lines!

You can start now by getting involved, getting trained and ensuring the media, politicians and corporations don't shame law abiding gun owners into failing to stand up for our 2nd Amendment rights. If we make the calls, we win. It's that simple. Don't leave it to someone else, let's burn up those phone lines!

## The Attraction of Shooting Sports

From Self-Defense to Shooting Sports, there is little doubt that more and more women are



becoming involved with firearms, training and shooting sports. Most women today start their firearm education and training for Self-Defense reasons. As they expand their training, many of these new-comers discover Shooting Sports.

From 2009 through 2018, the number of new "Target Shooters" has risen from 34.4 million to 52.1 million! Of that number, nearly 49% are women whose average age is 34. More and more shooters today come from the cities and suburbs. This is a big change from the past where the majority of female shooters were older and came mostly from rural and suburban areas.

This increase in women in Shooting Sports is due in part to an industry that has focused more on women shooters. They are no longer afraid of firearms and realize that guns are safe (when you follow the firearm safety rules) and shooting can be a fun activity.

Some of the local Women's Shooting League include Boondocks' GDG Shooting League which offers IDPA (International Defensive Pistol Association) and Outlaw Steel (speed shooting at steel targets). Another popular group of ladies is G.R.I.T.S.(Girls Really Into Shooting) – Mississippi Magnolia Chapter. This is all about shotguns and Sporting Clays ( a form of clay pigeon shooting) often described as "golf with a shotgun."

A flashlight can be an extremely valuable self defense tool. In situations like this, it can be not only a deterrent to a criminal, but can also prevent you from having to use a firearm to defend against a violent attack. Here are some key things to look for when selecting a flashlight to add to your EDC.
